Subject: Amendment of provision made under Para. 9.1 of the Tourism Policy-2013

No.8411-T.TSP-III-106/2014/TSM.— The State Government have announced the Tourism Policy, 2013 *vide* Tourism Department Resolution No. 4871-TSP--III-27/2013/TSM., dated the 17th April, 2013 and published in Extraordinary issue of *Odisha Gazette* bearing No.744, dated the 20th April, 2013.

The first part of Para. 9.1 of the Tourism Policy, 2013 “ This Policy proposes the formation of State Tourism Promotion Council (STPC), the apex body to guide and monitor the development of Tourism and various tourism related issued of the State. The STPC would be headed by the Hon’ble Chief Minister, Government of Odisha. The STPC will also act as the High Level Clearance Authority for Tourism Projects and will have members as shown below. The terms and conditions of the Council will be notified separately by the Government”, is deleted.

The following provision is substituted:—

“ The State Tourism Promotion Council (STPC) will be constituted as follows to act as the apex body to guide and monitor the development of Tourism in the State”.
