In pursuance of provision under clause 10.1 of Odisha Tourism Policy 2016, issued vide Tourism Department Resolution No.11487, dated the 24<sup>th</sup> November, 2016 and published in the Extraordinary issue of Odisha Gazette bearing number 2164, dated the 26<sup>th</sup> November, 2016, Government have been pleased to constitute the State Tourism Promotion Council (STPC), the apex body to guide and monitor the development of tourism and various tourism related issues of the State. The nominated members shall have a maximum tenure of 3 years unless renewed by the Secretary, Tourism. The STPC shall meet at least once in 12 months.


The State Tourism Promotion Council will review and monitor, the implementation of the Policy and suggest changes in the policy frame work.
