- Existing provisions under Clause 6.2 & 6.3 of the O.G. are deleted & substituted as – 'On receipt of recommendation of Special Single Window Clearance Committee (SSWCC) or State Level Single Window Clearance Authority (SLSWCA) or High Level Clearance Authority (HLCA); IDCO will initiate process for land allotment as per provisions detailed in Clause 8.1.1 of the Amended Odisha Tourism Policy- 2016.'
