4. Relevant information to the Tourists will be displayed through Departmental portal.

It is requested to take appropriate action in the light of above decision.





UNDER THE CHAIRMANSHIP OF PRINCIPAL SECRETARY TO GOVERNMENT, HOME DEPARTMENT.

The meeting for examination and revision of the guidelines for regulation of the visit of foreign tourists/ researchers to the areas inhabited and frequented by the particularly vulnerable groups (PVTG) was held on 17.12.2015 at 3.30 P.M. under the chairmanship of Principal Secretary, Home Department.

The officers attended the meeting is annexed as **Annexure- "A"**.

In the last meeting held on 14.10.2015, it was decided that the list of villages prepared by Director, Intelligence may be relooked and the list may be finalized taking into account security and tourist interest of the State. The revised list furnished by Director, Intelligence was examined and found suitable. The Director, Tourism presented a Advisory for visit of tourists to tribal areas. This was also examined. Commissioner-cum-Secretary, ST & SC Development Department identified 39 number of tourist guide to be imparted training by the Tourism Department.

After detailed discussion the following decisions were taken.


1. The list of restricted villages for foreign tourists furnished by Director, Intelligence was examined and after suitable modification

3. The Committee decided that the 39 potential tourist guides identified by ST & SC Development Department will be imparted training by the Tourism Department. The contents of the training and expenditure to be incurred in this respect will be worked out by Tourism Department. The expenditure for this purpose will be borne by ST & SC Development Department.

4. The Tourism Department and the ST & SC Development Department to provide all relevant information to the tourist through their departmental portals.
