1. Sealed Item rate bid is invited in single cover system from the Class of eligible registered agencies for the work: "**ORGANIZATION OF RAJARANI MUSIC FESTIVAL - 2023.**". Agencies not registered with Govt. of Odisha can participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Govt. before award of the work as per prevalent registration norms of the state.
  - a) This tender is of logistic arrangements for the event .
  - b) This detailed Tender Call Notice along with the clauses mentioned herein shall form a part of the contract.
2. The Bid documents are available on official website of Government: <https://dot.odisha.gov.in/> from **dt. 08.11.2023** to 15.00 Hours of **dt. 10.11.2023**. The last date and time of submission of Bid is as per contract data.
3. The Technical Bid documents will be opened by the assigned officer in the office of General Manager, OTDC Ltd. at **15.30 Hours on 10.11.2023** in the presence of the bidders or their authorized representatives who wish to attend.
4. Deleted.
5. The bid is to be submitted in two covers.
  - i) Cover-I is to contain registration certificate/ Trade License, PAN, profit-loss statement, list of similar nature of works, affidavit, turn over certificate and all other documents required as per the relevant clauses of this DTCN. The Agency belonging to outside of state of Odisha and not started business should submit an undertaking in the form of an affidavit indicating therein that they are not registered under Odisha as they have not started any business in the state of Odisha and they have no liability in Odisha. But before award of final contract, such bidders will have to produce the relevant authentic document.
  - ii) **Cover-II is to contain the PRICE BID duly filled in and signed by the bidder.**
6. Furnishing scanned legible copy of original registration certificate/ Trade License, PAN card along with the Technical Bid is mandatory otherwise his / her bid shall be declared as non responsive and thus liable for rejection.
7. The Agency in order to take part in the tender should enter in to an M.O.U. (Memorandum of Understanding) duly notarized with eligible registered electrical contractor having valid MV license; for execution of electrical installation and other electrical works and a copy of such

M.O.U. should be attached with the tender as per the proforma at **Schedule-C** which shall form a part of tender. A copy of electrical license should also be enclosed with the tender papers, the original of which need to be furnished during verification. The above M.O.U. is not required in case of the agency having valid registration in MV electrical license with the same name & style.

8. If an individual makes the application, the individual should sign above his full type written name and current address.
9. If the application is made by proprietary firm, it shall be signed by the proprietor & furnish full type written name and the full name of his firm with its current address in a forwarding letter.
10. If the application is made by a firm in partnership, it shall be signed by a partner holding power of attorney for the firm in which case a certified copy of the power of attorney shall accompany the application. A certified copy of the partnership deed and current address of all partners of the firm shall also accompany the application.
11. If the application is made by a limited company or a corporation, it shall be signed by a duly authorized person holding power of attorney for signing the application in which case a certified copy of the power of attorney shall accompany the application. Such limited company or corporation will be required to furnish satisfactory evidence of its existence along with the technical bid.
12. The tender should be strictly in accordance with the provisions as mentioned in the tender schedule. Any change in the wordings will not be accepted.
13. The work is to be completed in all respects within Three (3) days.
14. All tenders received during the scheduled period will remain valid for a period of 30 (Thirty) days from the last date prescribed for receipt of tenders and validity of tenders can also be extended if agreed by the tenderers and the tender inviting officer.
15. By admission of a tender for the work, a tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work.
16. The bid must be accompanied by bid security declaration / EMD of Rs.50,000.00 (Rupees Fifty thousand) Only.
17. The tender should be accompanied with the scanned copies of the valid registration certificate/Trade License, GST Certificate, PAN card & MOU with Electrical Contractor which are mandatory, otherwise his / her bid shall be declared as non-responsive and thus liable for rejection. The Agency belonging to outside state of Odisha and not started business should submit an undertaking in the form of an affidavit indicating therein that they are not registered under Odisha as they have not started any business in the state of Odisha and they have no

liability in the state of Odisha. But before award of final contract, such bidders will have to produce the relevant authentic document.

18. The tender containing extraneous conditions not covered by the tender notice are liable for rejection and quotations should be strictly in accordance with the items mentioned in the Tender Call Notice. Any change in the wording will not be accepted.
19. The department reserves the right of authority to reject any or all tenders received without assigning any reason whatsoever.
20. The earnest money of the L1 bidder will be retained and will be dealt with as per terms and condition of the DTCN. The retention of E.M.D. with the Odisha Tourism Development Corporation Ltd. will carry no interest.
21. The Engineer-in-charge will notify the bidder / tenderer whose bid has been accepted for the award prior to expiration of the validity period by cable, telex or facsimile confirmed by registered letter. This letter (hereinafter and in the conditions of Contract called the "Letter of Acceptance") will state the sum that the Engineer-in-charge will pay the contractor in consideration of the execution of the Works by the agency as prescribed by the contract (Hereinafter and in the contract called the "Contract Price").
22. The notice inviting bid, all the documents including additional conditions, specifications and drawings, if any, forming the bid as issued at the time of invitation of bid and acceptance thereof together with any correspondence leading thereto & required amount of performance security including additional performance security.
23. Failure to enter in to the required agreement and to make the security deposit as above shall entail forfeiture of the Bid Security (earnest money). No contract (tender) shall be finally accepted until the required amount of initial security money is deposited. The security will be refunded after 15 (fifteen) days of completion of the work and payment of the final bill and will not carry any interest. As concurred by Law Department & Finance Department In their U.O.R. No 848, dt.21.05.97 J.O.R.No.202 W.F.D. dtd.06.03.98 respectively the E.M.D. will be forfeited in case, where tenderers back out from the offer before acceptance of tender by the competent authority.
24. The contractor should be liable to fully indemnify the Odisha Tourism Development Corporation Ltd., Bhubaneswar for payment of compensation under workmen compensation act. VIII of 1923 on account of the workmen employed by the contractor and full amount of compensation paid will be recovered from the contractor.
25. After the work is finished all surplus materials should be removed from the site of work.

## TERMS & CONDITIONS

1. All the programme, trial & testing and decoration lighting shall be run on Generator.
2. All rates are quoted for the full period including Stage Light & Sound and other arrangements inclusive of trial testing, transportation, dismantling and cleaning of site but exclusive of taxes.
3. The illumination of the temple segment may change as per the instruction of the Light Designer or the authority of OTDC / DOT.
4. The Generators will operate from 04.00PM to end of the show and for trial testing on all 04days (i.e. from 14.11.2023 to 17.11.2023). The illumination shall be from 04.00PM to 12.00 Midnight.
5. Main cables and wires, colour filters, Speaker Stands, Switch Board and Stabilizer and other accessories shall be provided as per requirement.
6. Proper communication systems through walky talky or otherwise among light operator, follow spot operator, sound operator, stage coordinator, light designer, sound specialist etc will be provided by the tenderer. Sufficient manpower shall be stationed at the venue during the programme hours for coordination and trouble shooting.
7. The successful bidder shall arrange for electricity supply, if required and clearance from the Electrical Inspector at his/her own cost used during the event period without failed.
8. The successful bidder shall produce list of equipments and work done each day at the end of the programme and get it signed from the concern J.E. (Civil), J.E.( electrical) and Officer-in-charge of the festival.
9. The authority reserves the right to increase or decrease the scope of work as per the site requirement in which case, payment shall be made only on the actual work done on unit rate basis.
10. **Terms of payment:**50% of work order value will be released after the completion of the work and handing over the site and the balance payment will be released within 15days from the completion of the event.
